WHEREAS, the Securities Division of the Office of the Attorney General of the State of South Carolina (the "Division") has been authorized and directed by the Securities Commissioner of South Carolina (the "Securities Commissioner") to administer the provisions of S.C. Code Ann. § 35-1-101, *et seq.*, the South Carolina Uniform Securities Act of 2005 (the "Act"); and

WHEREAS, the Division received information regarding alleged activities of Elliot Orlando Davis (d/b/a Hush, Inc., d/b/a Hush Entertainment, Inc., d/b/a Heavyweight Entertainment, Inc.) ("Elliot Davis" or the "Respondent") that, if true, would constitute

4. In or about July 2016, four (4) South Carolina investors (the "Investors") invested a collective total of fifty thousand dollars (\$50,000) with the Respondent to bring performing artist Gucci Mane to Greenville, South Carolina.
5. The Respondent and the Investors signed a joint venture contract, pursuant to which the Investors were promised a return of double their investment. The Respondent was to handle all matters related to the concert's occurrence and success, including but not limited to

Division as a broker-dealer, and no exemption from registration has been claimed.

14 At no time relevant to the events stated herein were the securities of issue registered with

d/b/a Hush Entertainment, Inc., d/b/a Heavyweight Entertainment, Inc.) shall pay a civil penalty in the amount of one hundred twenty thousand dollars (\$120,000) if this Order becomes effective by operation of law, or, if Elliot Davis seeks a hearing and any legal authority resolves this matter, pay a civil penalty in an amount not to exceed \$10,000 for each violation of the Act by Elliot Davis and the actual cost of investigation or

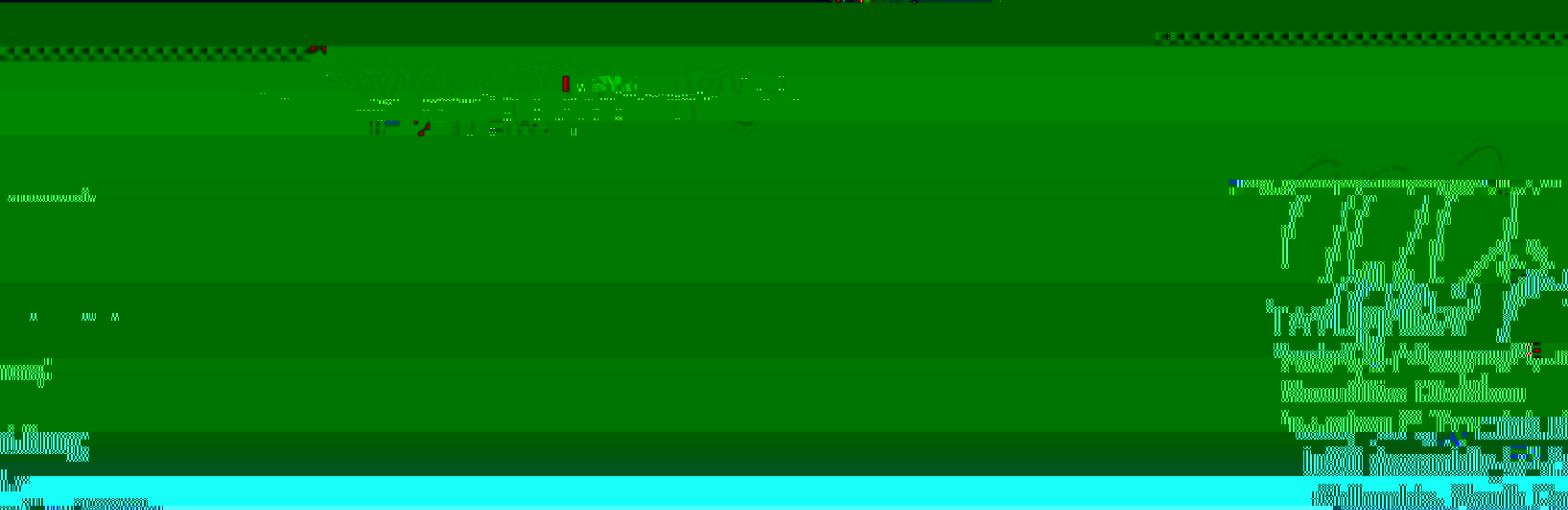
IT IS FURTHER ORDERED that pursuant to S.C. Code Ann. §§ 35-1-604(a)(2) and (3),

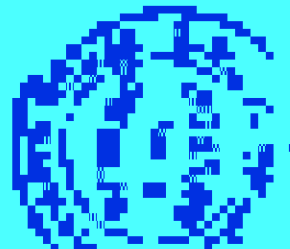
